Requirements & Guidelines

The sale will be held on April 20, 2019 at 12 noon at the Porth Agricultural Arena in Crockett, Texas. Consignors must be a current member or become members of ETLBMG. Your check for \$30 payable to ETLBMG must be included with your consignment form.

We will accept 60 lots for the sale. The Sale Manager will have the authority to accept or reject any animal nominated, to insure 60 lots. All cattle will be assessed by the Sale Manager or Jerry Hemphill prior to being accepted.

The sale will include a Heifer Futurity for Open & Bred Heifers. Futurity entries must be entered when consigned and cataloged as such. All futurity lots must sell. There will be no late entries. The Futurity will be held Friday evening. ETLBMG will select a futurity judge. The Futurity judge’s name may not be announced prior to the Futurity.

Nomination Deadline is January 14, 2019.

ETLBMG Sale Nomination fee is \$100 per lot and is non-refundable.

Nomination Fee \$50(applied to sales expenses).

Assessment Fee \$50(Paid for Assessment by Sale Management/Hemphill).

ETLBMG Sale Futurity Fee is \$200 per lot and is non-refundable.

Futurity Fee & Awards \$100

Nomination Fee \$50(applied to sales expenses)

Assessment Fee \$50(Paid for Assessment by Sale Management/Hemphill).

Assessment fee *by Sale Management will be \$50 per lot not to exceed \$150 per consignor.*

Display Pens will be \$200 each if space is available.

Display Booths will be \$50 each.

ETLBMG Requirements

- All cattle must be “Purebred” Beefmaster cattle.
- All nominations will be assessed prior to acceptance for consignment.
- Cattle are not required to be classified but must meet the classification standard of U2 or better for conformation and 3 or better for underline.
- Cattle must meet a minimum body condition score of 5.
- Late consignments will be at the discretion of the Sale Manager but must meet sale standards.
- Substitutions may be considered, but would be subject to assessment and acceptance of these cattle at the sale site.

Health Papers must include:

Cattle must be listed on the health certificate with the animal's permanent ID# (Traceability Requirements). If you have any questions, check with your vet or go to www.tahc.state.tx.us.

All health certificates must be done within 30 days of sale date.

Texas is a Brucellosis and TB Free State. You are not required to Brucellosis & TB Test. Please check with your vet for any other requirements for your area.

Bulls – Health paper on each animal

BSE form (provided) on each animal to include Fertility Test and Scrotal circumference

Trich Test on each bull 12 months and older.

Females – Health paper on each animal

Palpation information must be written on the health paper.

If the female is open or exposed, please state so on the health paper.

Please check with your vet if there are any other requirements.

Guidelines for Cattle Consigned:

- **Herd Bulls & Herd Bull Prospects:** 18 months to 48 months of age maximum. **ONLY THE TOP BULLS WILL BE ACCEPTED.** All bulls must be Trich tested. No virgin affidavits will be accepted.
- **3-in-1's or Pairs** - Age limit up to 72 months of age(6 years). Any female with a calf at side that is over 6 months of age must be palpated safe in calf and this information stated on the health paper.
- **Bred Cows** – Age limit up to 72 months of age(6 years). Bred cows must be heavy bred and of exceptional quality.
- **Bred & Exposed Heifers** - Age limit up to 36 months of age. Any heifer over 24 months of age must be palpated safe in calf by a licensed vet and information must be included on the health paper.
- **Open Heifers** – age limit up to 20 months of age – These heifers will be guaranteed open and certified by a licensed vet and so stated on the health paper. **All Open Heifers must be less than 20 months of age and we will only accept 15 head.**
- **Special Lots** - Donors, Flushes, Embryos, etc. will be accepted. If they do not qualify in a futurity, the Sale Manager will determine where they sell in the sale order.

FUTURITY CATTLE

Bred Heifers – must be less than 30 months of age.

Open Heifers – must be less than 20 months of age.
